Location Details





Kirkwall Sheriff Court sits between the Historic Scotland sites of the Earls and Bishops Palaces.
Kirkwall Sheriff Court covers the whole of the Orkney Islands area.

The public façade of the courthouse faces over the Bishop's Palace grounds towards Palace Road. The main entrance is raised above pavement level and is accessed by a series of 4 steps.


For users with restricted mobility there is a ramp provided to the side of the steps.

By Ferry




The main Ferry Terminal in Kirkwall is located 0.5 miles away from the Court House.

The public entrance is accessed via steps and a footpath from Watergate. An alternative level route is available from Place Road. The access is by four steps, or by a side ramp for those with restricted mobility.

There is an intercom at the front door for those who require assistance entering the building.

Facilities



Toilets

There are toilets on the first floor.



An accessible toilet is available at ground floor level.

Signage

High contrast signage is provided around all circulation areas to ensure the public zones are easily navigated.



Refreshments

There are a small number of cafes and hotels near to the court building where meals and snacks can be purchased. There are no refreshment facilities at the court. If you are sitting jury, lunch and refreshments will be provided for you if the court sits into the afternoon.



Hearing Loop

For people who are hard of hearing a fixed loop induction service is available at the public counter. Portable mobile loop induction services are available for the courtrooms.

On arrival please inform the Court Officer if you require this facility.

Courtrooms

The courtroom is well lit, spacious and has good acoustic qualities including full induction loop facilities.

While no provision is given for wheelchair users to access the seated area in the public gallery or the witness box, the space in the court room is ample.

When accessing the court itself, assistance will be needed to use the stair lift.

Lifts

There is no lift within the property, however a seated stair lift is available.

Wheelchair users will need to transfer to the stair lift and will require assistance to transfer their wheelchair to the first floor.



Typical Jury room




Fines and Criminal Office


Public Office
