



SHERIFFDOM OF SOUTH STRATHCLYDE DUMFRIES AND GALLOWAY

Order Refixing Diets: No 11 of 2021

in respect of Summary Sheriff Court Criminal Business

in Hamilton Sheriff Court

In relation to the following categories of summary sheriff court criminal business certain diets have been assigned for dates which are no longer suitable to the court, namely:

- (i) All cases calling in the cited courts between 1 March 2021 and 31 March 2021 (inclusive) (except those in relation to which a letter pleading guilty or not guilty has been tendered);
- (ii) All cases calling in the summary trials courts between 1 March 2021 and 12 March 2021 (inclusive) except (i) those where the accused is in custody in relation to the case calling; (ii) part heard trials; and (iii) those identified as a priority.

In accordance with the power set out in section 137ZB of the Criminal Procedure (Scotland) Act 1995, the court, of its own accord, hereby discharges each of the said diets assigned for the dates specified in column A of Schedules 1 and 2 to this Order and fixes new diets as follows:


1. In respect of all cases calling in the cited courts (except those in relation to which a letter pleading guilty or not guilty has been tendered) on the date specified in column A of Schedule 1 to this Order, a new diet will be fixed for the date set out in column B of the same row in the said Schedule;
2. In respect of all cases calling in the summary trials courts on a date specified in Column A of Schedule 2 to this Order where an intermediate diet has been held pertaining to that trial prior to 1 March 2021 (except (i) those where the accused is in custody in relation to the case calling; (ii) part heard trials; and (iii) those trials identified as a priority), the trial diet will be discharged and a new trial diet will be fixed for a date set out in column B of the same row in the said Schedule.

3. In respect of all cases in which an accused person has a deferred sentence calling in the same court and on the same date as a trial diet which has been discharged by virtue of this Order, a new diet of deferred sentence will be fixed for the same day as the new trial diet as the case may be.

The details of those trials which are (i) part heard; (ii) in respect of which the accused is in custody in relation to the case calling; or (iii) identified as a priority and which **will** proceed on the date allocated between 1 March 2021 and 12 March 2021 are listed in Schedule 3 to this Order.

Between 1 March 2021 and 31 March 2021 (both dates inclusive), all sentencing diets (except those referred to in paragraph 3 above) will call on the dates assigned. In respect of all cases calling for any other matter (such as a breach proof for a community payback order or a debate), except those in relation to which an accused is in custody, the case will call on the date assigned, the attendance of the accused will be excused and the case will be adjourned to a future date *ex proprio motu* without the need for representation on behalf of the accused.

The Sheriff Clerk is appointed to intimate said new diets to parties.
