SHERIFFDOM OF NORTH STRATHCLYDE

Order in respect of Summary Criminal Business

Refixing of Justice of the Peace court Diets

No. 2 of 2021

In relation to the following categories of summary criminal business calling in the Justice of the Peace court in the weeks specified in column A of the Schedules to this guidance, certain diets have been assigned for days which, are no longer suitable to the court, namely:

1. All cases calling in the cited courts (excepting those where the accused is in custody);
2. All cases calling in the intermediate diet courts (excepting those where the accused is in custody)
3. All cases calling in the trials courts (excepting those where the accused is in custody);

In accordance with the power set out in section 137ZB of the Criminal Procedure (Scotland) Act 1995 (“the 1995 Act”), the court, of its own accord, hereby discharges the said diets assigned for the dates specified in column A of the Schedules to this guidance and fixes new diets as follows:

1. In respect of all cases calling in the cited courts in a week on a day specified in column A of the Schedule 1 to this guidance, a new diet will be fixed for the day set out in column B of the same row in the Schedule;
2. In respect of all cases calling in the intermediate diet courts (excepting those where the accused is in custody, and those in which a trial diet is presently assigned for a date on or after 1 March 2021) in a week specified in column A of Schedule 2 to this guidance, a new intermediate diet will be fixed for the week set out in column C of the same row in the Schedule and a new trial diet will be fixed for the week set out in column B of the same row in the Schedule;

3. In respect of all cases calling in the summary trials courts where an intermediate diet has been held pertaining to that trial prior to 12 January 2021 (excepting those where the accused is in custody) in a week specified in column A of Schedule 2 to this guidance, a new intermediate diet will be fixed for the week set out in column C of the same row in the Schedule and a new trial diet will be fixed for the week set out in column B of the same row in Schedule 2;

The Sheriff Clerk will intimate to parties the new date fixed in terms of section 137ZB forthwith.
