



**Refixing Diets upon the Death of Her Majesty, Queen Elizabeth II
in respect of Criminal Business in Paisley Justice of the Peace Court**

Order No 8. of 2022

Diets assigned to call on 19 September 2022 in Paisley Justice of the Peace Court are no longer suitable to the court.

In accordance with the powers set out in section 137ZB of the Criminal Procedure (Scotland) Act 1995 ("the 1995 Act"), the court of its own accord hereby discharges those diets specified in Column A of Schedule 1 to this Order, which had been assigned to call in Paisley Justice of the Peace Court on 19 September 2022, in respect of summary criminal proceedings with the procurator fiscal reference number referred to in the same row in Column B involving the accused named in the same row in Column C and fixes a new diet in each of the proceedings for the date specified in Column D.

The Sheriff Clerk is appointed to intimate said new diets to parties.
