# AIRDRIE, HAMILTON AND LANARK SHERIFF COURTS

## in Respect of the Transfer of Solemn Trial Diets

This Order supersedes the Order of Court No 6 of 2023 dated 20 November 2023 with effect from 24 November 2023.

## Introduction

All references in this Order to a Sheriff Court shall be construed as a reference to the relevant Sheriff and Justice of the Peace Court.

Part 1 of this Order supersedes Part 2(i) of the Order of Court No 24 of 2020 with effect from 8 January 2024.

This Order returns solemn trials diets to Lanark Sheriff Court with effect from 8 January 2024.

Part 2 of this Order supersedes Order of Court No. 2 of 2023 with effect from 8 January 2024.

Due to exceptional circumstances which could not reasonably have been foreseen, it is not practicable for Airdrie Sheriff Court to proceed with some or all proceedings on indictment due to call at diets from 8 January 2024.

This Order transfers to Hamilton Sheriff Court and Lanark Sheriff Court some solemn trial diets which would ordinarily call at Airdrie Sheriff Court, with effect from 8 January 2024 and dates thereafter.

This Order does not affect any other diet in solemn proceedings (including but not limited to First Diets, Continued First Diets, Diets in terms of Section 76 of the Criminal Procedure (Scotland) Act 1995 and Sentencing Diets).

This Order is made pursuant to the powers vested in me in terms of Section 83ZA of the Criminal Procedure (Scotland) Act 1995.

#### Part 1 - Return of Solemn Trials to Lanark Sheriff Court

From 8 January 2024 and thereafter, I hereby Order that:

(i) All solemn trials which were due to call at Lanark Sheriff Court and which had been transferred to Airdrie Sheriff Court by virtue of the Order of Court No 24 of 2020, shall be adjourned to a trial diet at Lanark Sheriff Court on the same date as the date on which the trial diet is next due to call.

# Part 2 – Transfer of Solemn Trials from Airdrie Sheriff Court to Hamilton and Lanark Sheriff Court.

From 8 January 2024 and thereafter, I hereby Order that:

Solemn trial diets listed in the attached Schedule 1, which were due to call at Airdrie Sheriff Court on or after 8 January 2024, are adjourned to a trial diet at Lanark Sheriff Court on the same date as the date to which the trial diet is next due to call.
