#### IN RESPECT OF SOLEMN AND SUMMARY CRIMINAL BUSINESS

#### **Sheriff Court and Justice of the Peace Court: Transfer of remaining Dunfermline and Kirkcaldy cases to Kirkcaldy Sheriff Court**

This Order transfers all cases from 16 June 2020 onwards which would ordinarily call in Dunfermline or Kirkcaldy Sheriff and Justice of the Peace Courts (but which would currently call in Falkirk Sheriff and Justice of the Peace Courts as a result of the "Order in respect of Solemn and Summary proceedings No 1 of 2020", hereinafter referred to as "Order No 1") to call at Kirkcaldy Sheriff and Justice of the Peace Courts.

This Order is made pursuant to the powers vested in me in terms of sections 83ZA and 137AA of the Criminal Procedure (Scotland) Act 1995 ("the 1995 Act").

For the avoidance of doubt, this Order takes precedence over Order No 1 where both Orders apply to a case.

## Part 1

From 16 June 2020, I hereby order:

- (1) The transfer to Kirkcaldy Sheriff Court of all proceedings on indictment which were transferred from Dunfermline Sheriff Court and Kirkcaldy Sheriff Court to Falkirk Sheriff Court in terms of Order No 1 and the adjournment of said proceedings to a diet at Kirkcaldy Sheriff Court on the same date as the diet to which the case is next to call or to such other diet as may be fixed by the court in terms of Section 75C or as the case may be Section 75A of the 1995 Act.
- (2) The transfer to Kirkcaldy Sheriff Court of all proceedings on indictment assigned to call at a diet in Dunfermline Sheriff Court from 1 July 2020 onwards and the adjournment of said proceedings to a diet at Kirkcaldy Sheriff Court on the same date as the diet to which the case is next to call or to such other diet as may be fixed by the court in terms of Section 75C or as the case may be Section 75A of the 1995 Act.
- (3) The transfer to Kirkcaldy Sheriff and Justice of the Peace Courts of all proceedings in summary cases which were transferred from Dunfermline and Kirkcaldy Sheriff and Justice of the Peace Courts to, and remain at, Falkirk Sheriff and Justice of the Peace Courts (i) in terms of Order No 1 or (ii) by an order under section 137A or section 137CA of that Act between 26 March 2020 and 15 June 2020 both dates inclusive; and the adjournment of said proceedings to a diet of Kirkcaldy Sheriff and Justice of the Peace Courts on the same date as the diet to which the case is next to call.

**Part 2**

This Order comes into force on 16 June 2020 and will endure until and including 1 August 2020 or such other date as may be separately ordered.
