### ORDER

#### IN RESPECT OF SOLEMN AND SUMMARY PROCEEDINGS

#### SOLEMN PROCEEDINGS

In accordance with the power vested in me in terms of section 83ZA of the Criminal Procedure (Scotland) Act 1995, I hereby order

- (1) the transfer to Dundee Sheriff Court of all proceedings on indictment to call at a diet in the following court (hereinafter "the original court"): Perth Sheriff Court, and the adjournment of said proceedings to a diet at Dundee Sheriff Court on the same date as the diet initially assigned at the original court; or to such other diet as may be fixed by the court in terms of Section 75C or as the case may be Section 75A of the Criminal Procedure (Scotland) Act 1995
- (2) the transfer to Falkirk Sheriff Court of all proceedings on indictment due to call at a diet in the following courts (hereinafter "the original court"): Dunfermline Sheriff Court, Kirkcaldy Sheriff Court and Stirling Sheriff Court, and the adjournment of said proceedings to a diet at Falkirk Sheriff Court on the same date as the diet initially assigned at the original court. or to such other diet as may be fixed by the court in terms of Section 75C or as the case may be Section 75A of the Criminal Procedure (Scotland) Act 1995

## SUMMARY PROCEEDINGS

In accordance with the power vested in me in terms of section 137AA of the Criminal Procedure (Scotland) Act 1995, I hereby order

- (1) the transfer to Dundee Sheriff and Justice of the Peace Court of all proceedings in summary cases (where the accused is in custody) due to call at a diet in the following courts (hereinafter "the original court"): Perth Sheriff and Justice of the Peace Court and Forfar Sheriff and Justice of the Peace Court, and the adjournment of said proceedings to a diet of Dundee Sheriff and Justice of the Peace Court on the same date as the diet initially assigned at the original court;
- (2) the transfer to Falkirk Sheriff and Justice of the Peace Court of all proceedings in summary cases (where the accused is in custody) due to call at a diet in the following courts (hereinafter "the original court"): Alloa Sheriff and Justice of the Peace Court, Dunfermline Sheriff and Justice of the Peace Court, Kirkcaldy Sheriff and Justice of the Peace Court and Stirling Sheriff and Justice of the Peace Court, and the adjournment to a diet of Falkirk Sheriff and Justice of the Peace Court on the same date as the diet initially assigned at the original court.

This Order comes in to force on 26<sup>th</sup> March 2020 and will endure until and including 30 June 2020 or such later date as may be separately ordered.
