COURT HOLIDAYS AND CUSTODY COURT ARRANGEMENTS 2024

I, SEAN F MURPHY KC, Sheriff Principal of the Sheriffdom of North Strathclyde, by virtue of the provisions of Section 28(1) of the Courts Reform (Scotland) Act 2014 and Sections 8(2) and 8(3) of the Criminal Procedure (Scotland) Act 1995, as amended, do HEREBY prescribe:

- (a) Those days specified in Column A of Schedule 1 attached to this Act of Court as Court holidays for those courts within the Sheriffdom specified in Column B of Schedule 1 in the period to January 2025; and
- (b) That there will be a sitting for the disposal of criminal business on those dates specified in Column A of Schedule 2 in those courts specified in Column B of Schedule 2 if necessary to deal with any person in custody in respect of criminal business emanating from the courts specified in Column C of Schedule 2.
